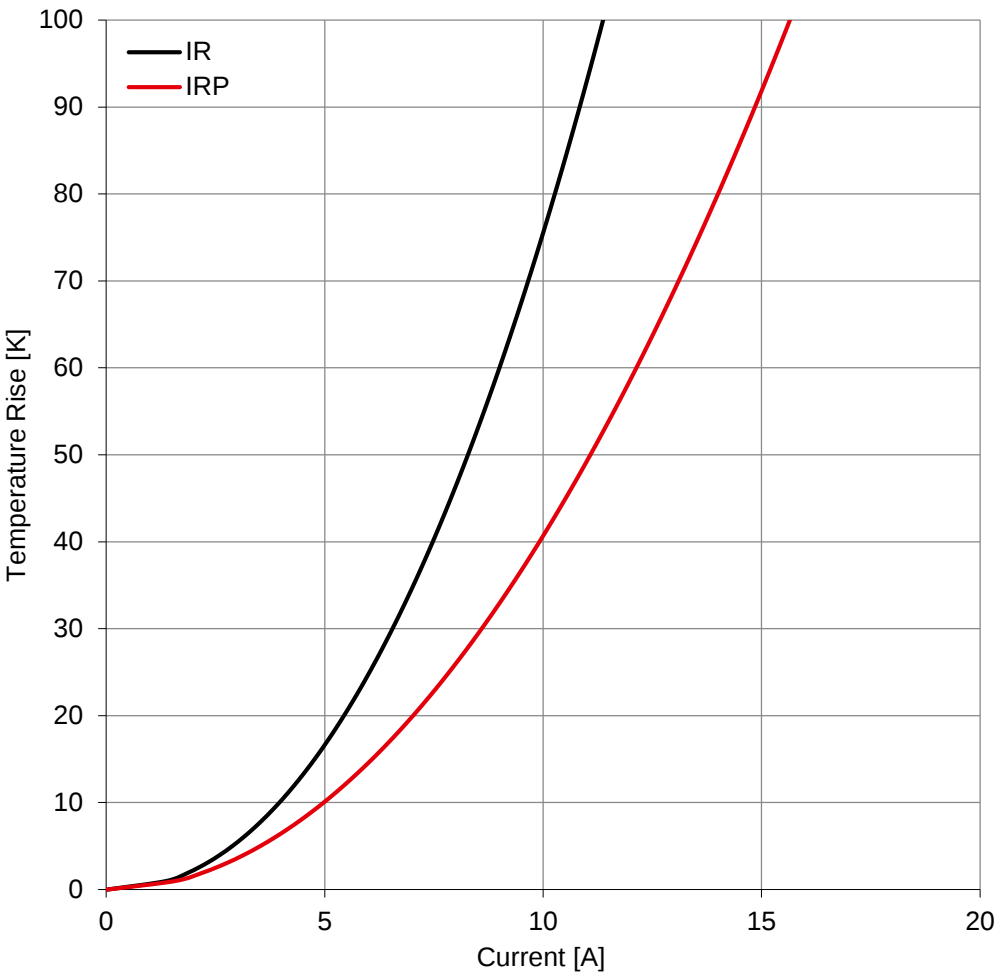

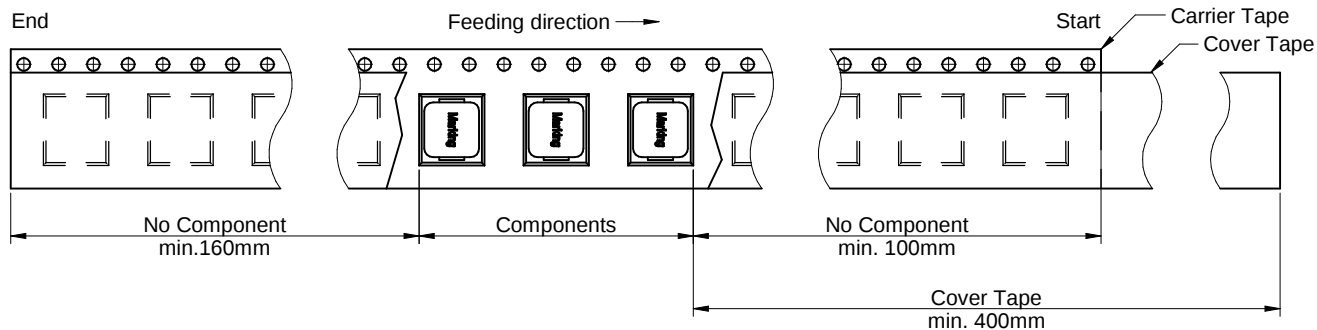
Technical drawing of a battery pack showing top and side views with dimensions.

Soldering:

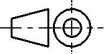

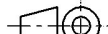
